

# WHAT'S NEW IN INTERIM BUDGET 2024

**KEY HIGHLIGHTS ON TAXES, PERKS AND PLANS** 

## DEVELOPMENT

- Through roof-top solarisation, 1 crore households will be enabled to obtain up to 300 units of free electricity every month
- Plan to build 2 crore affordable houses in 5 years
- For tech-savvy youth, a corpus of Rs 1 lakh crore will be established with 50-year interest free loan
- Aim to make India 'VIKSIT' (developed) by 2047

### TAXATION

- No changes in taxation, both direct and indirect
- Propose to extend tax exemptions for some International Financial Services Centre (IFSC) to March 31, 2025
- To withdrew old disputed direct tax demands of up to Rs 25,000 till FY10, and Rs 10,000 for 2010-11 to 2014-15

- FY25 fiscal deficit seen at 5.1% vs FY24 revised estimate of 5.8%







GSTN issued Advisory As per Notification No.26/2022 – Central Tax dated 26th December 2022 two new tables Table 14 and Table 15 were added in GSTR-1 to capture the details of the Supplies made through ecommerce operators (ECO) on which ecommerce operators are liable to collect tax u/s 52 of the Act or liable to pay tax u/s 9(5). GSTN issued Advisory to facilitate the taxpayer registered under GST with more methods of payment, two new facilities of payment have now been provided under epayment in addition to net banking. The two new methods are Cards and Unified Payments Interface (UPI). Cards facility includes Credit Card (CC) and Debit Card (DC) namely Mastercard, Visa, RuPay, and Diners (CC only) issued by any Indian Bank. Please click here for the complete advisory.

#### E-way Bill

NIC issued Advisory as per Notification No.78/2020 Central Tax,

dated October 15th 2020, it is necessary to provide at least 6 digit HSN code for all the B2B and Export transactions by the taxpayers whose Annual Aggregate Turnover (AATO) is more than ₹5 Crores. The taxpayers, with AATO less than ₹5 Crores, need to provide at least 4 digit HSN code.

This validation will be implemented in the eway bill System from February 1st 2024. Hence, the taxpayers are advised to make necessary changes in their systems and enter 4/6 digit HSN codes while generating the eway bills through web and API systems from February 1st 2024

#### GST Notification No.01/2024 – Central Tax (Rate) dated January 3rd 2024

CBIC notifies 5% GST on LPG (Non-Automotive) as per Standard IS 4576. Similar notifications have been passed under the Integrated Goods and Services Tax Act, 2017 and the Union Territory Goods and Services Tax Act, 2017.

### GST Notification No.01/2024 – Central

Tax dated January 5th 2024 CBIC extended the deadline for filing the GSTR-3B return for November 2023 to January 10, 2024. This extension applies to registered taxablepersons with a principal place of business in specific districts of Tamil Nadu (Tirunelveli, Tenkasi, Kanyakumari, Thoothukudi,

and Virudhunagar). The decision is based on the recommendation of the Council and is exercisedunder the authority of section 39(6) of the Central Goods and Services Tax Act, 2017 effective from December 20th 2023.

Tax dated January 5th 2024 CBIC extended the due date for filing GSTR-9 and GSTR-9C for the financial year 2022-23 in response to recent floods in certain districts ofTamil Nadu. The original deadline was December 31st 2023, but for registered persons with their principal place

of business in specific flood-affected districts, including Chennai, Tiruvallur,

Chengalpattu, Kancheepuram, Tirunelveli, Tenkasi,

Kanyakumari, Thoothukudi and Virudhunag ar, the new deadline is January 10th 2024.


